GENERAL CONDITIONS

The Committee reserves the right from time to time to alter the date of running, to make any alterations or modification in this race, to cancel the meeting or any portion thereof, and to alter the time of taking entries, declaration of handicaps or acceptances, also to reject at any time any entry submitted to or for them. Entries are received on the condition that the Rules of Racing, By-Laws and Regulations of the Tasmanian Turf Club, now and hereafter in force are binding in all respects.

BALLOTING CONDITONS

In accordance with LR 31 © (ratings based handicapping balloting at the time of final acceptance).

(1) Method of elimination of surplus horses; elimination must be effected in order from the horse or horses with the lowest ballot ratings figure upwards as follows:

- (a) Horses with the lowest ballot rating will be eliminated first
- (b) When two or more horses are of the same ballot rating oldest will be eliminated first
- (c) When two or more horses are of the same ballot rating and age elimination shall be in order of lowest aggregate prize money received.

(2) Adjustments - penalties after declaration of weights; For the purpose of elimination pursuant to LR 28 (f), if the condition of the race provide for penalties for wins after the declaration of weights, the Handicapper may promote minimum horses in the elimination order by altering their ballot rating, which shall not affect their weight in the race.

The minimum top weight at declaration of weights in any Handicap flat race shall be 58kg. (AR103)

Further provided that the Committee of the Club may in its absolute discretion eliminate any horse from this race, or exclude any horse from the operation of these balloting conditions. In the event of a horse being eliminated under the balloting conditions, only the final declaration fee will be refunded.

SCRATCHING FEE:

A scratching fee of \$400 including GST will apply to the above three events unless a Veterinary Certificate is tendered or an emergency takes the place of the scratched horse. In the event of a horse being eliminated under the balloting conditions, only the final declaration fee will be refunded.
